1 Welcome from Chairman

7 Business

a. W/20/00299/PRMV – Application for Variation of Premises Licence – Wild Rabbit, Church Street, Kingham (comment by 03 July 2020) – to respond to application

It was **resolved** to seek clarification from the Licensing Officer regarding the term "resident" as it relates to those within the bounds of the hotel and those using the surrounding cottages. It was **resolved** to comment as follows:

- A) To approve the extension of the sale of alcohol from 11.00pm to midnight for non-residents within the main building.
- B) To approve the extension of the sale of alcohol from 11.00pm to midnight for non-residents using the Chicken Shed/private dining rooms.
- C) To approve Late Night Refreshment only if it relates solely to residents within the bounds of the hotel.

Action: Clerk to request clarification and forward council comments.

b. To respond to request from The Kingham Plough to put picnic benches on the grass in front of the pub when it reopens

It was **resolved** not to grant permission for picnic benches to be placed on the grass (The Village Green) in front of the pub when it reopens.

Action: Clerk to inform publican of Council decision.

c. Report received of hedge along east side of Cozens Lane growing out over the road potentially causing traffic obstruction – to comment and agree action

It was **resolved** to ask resident to cut the hedge back to the wall line.

d. Report received querying the positioning of timber used to retain soil of new garden in Cozens Lane – to comment and agree action

It was **resolved** to ask resident to chamfer off edge of timber to reduce potential hazard.
